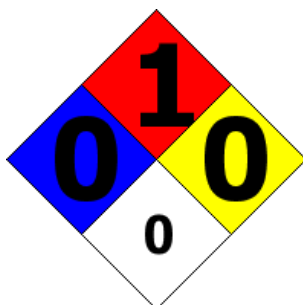

Description of first aid measures

Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use or handling.
